### SCHOLARSHIPS TO ALA ANNUAL CONFERENCE REGIONAL CONFERENCE OR GET YOUR ALA OR OC-ALA DUES PAID BY OC-ALA

This year we are proud to offer almost \$20,000 in scholarships for Annual and Regional Conferences and ALA and OC-ALA Dues to the most active and involved OC-ALA Members. Collect ORANGES (points) to win! How do you collect ORANGES? There are many ways to collect ORANGES! Attend meetings, refer new members or business partners, write an article for the e-newsletter and/or update your profile on our website. The more ORANGES you collect the higher your "points," and the more likely you are to win. The list of events and activities included are on the attached sheet. Thanks to our 2011 Business Partners, we are able to offer these increased benefits to our members.

## WHAT CAN I WIN?

We will award the following:

- Regional Conference – Las Vegas, NV, October 2011: **Four** Scholarships valued at \$600 each and **Four** Scholarships valued at \$325 each.
- Annual Conference – Honolulu, Hawaii, April 2012: **Six** Scholarships valued at \$2,000 each and **Four** Scholarships valued at \$800 each.
- ALA Headquarters Annual Dues – **Four** Annual Dues valued at \$320 each
- OC-ALA Annual Dues – **Four** Annual Dues valued at \$60 each

## WHEN DO I WIN?

1. July General Meeting (July 2011) – Collect ORANGES from April 1 to July 15 to be eligible for one of **Eight** Regional Conference Scholarships
2. Business Partner Appreciation Event (October 2011) -- Collect ORANGES from July 16 to October 15 to be eligible for one of **Four** ALA Annual Dues Renewals and **Four** OC-ALA Annual Dues Renewals
3. Managing Partner Holiday Lunch (December 2011) -- Collect ORANGES from April 1 to December 1 to be eligible for one of **Six** Annual Conference Scholarships

4. ACES (February 2012) – Collect ORANGES from December 2 to February 1 to be eligible for one of Four Annual Conference Scholarships

## **HOW DO I WIN?**

It's simple. Collect ORANGES by being an active member of OC-ALA. For example, the top **Eight** ORANGE-earners will win the Regional Scholarships at the July general meeting. You don't have to present to win (although you won't receive any ORANGES for that day).

## **WHO IS KEEPING TRACK OF ORANGES?**

The Board will keep a master list and record ORANGES for you. You must sign in at all meetings to collect ORANGES. It's ok to remind a board member to make sure you get proper credit! The Treasurer-Elect maintains the master list of earned ORANGES.

## **FINE PRINT**

Elected Board Members are not eligible to win Regional Scholarships. President and President-Elect are not eligible to win Annual Scholarships or Dues Renewals. Members are responsible for making sure ORANGES are recorded by the Chapter's Treasurer-Elect. Recipients of scholarships can only win one scholarship, but are still eligible for ALA and OC-ALA dues awards. This system is intended to reward our members who actively participate in the Chapter.
